These Terms set forth the terms and conditions under which you may use my Website and services as offered by me. This Website offers visitors information about my business. By accessing or using the Website, or by contacting me for the purpose of being treated, you approve that you have read, understood, and agree to be bound by these Terms.

## 2. Applicable Law

### 3. Intellectual Property

I take payment after a treatment is completed at the agreed date and time with you, whether written or oral. You have the right to cancel an appointment with me at any time, however you must give reasonable notice.

Gift cards/vouchers are valid for 1 year from date of purchase.

### 6. Retention of Right to Change Offering

I may, without prior notice, change the Assets; stop providing the Assets or any aspects of the Assets I offer; or create limits to the Assets. I may permanently or temporarily terminate or suspend access to the Assets without notice and liability for any or no reason.

### 7. Indemnification
